

## **STANDARD COMPETITION TERMS AND CONDITIONS**

1. The promoter of this competition is RCS Cards Proprietary Limited (“RCS”) (NCRCP 38/FSP 44481) with its registered address at Golf Park 6, Raapenberg Road, Mowbray (hereinafter referred to as “RCS”).
2. All persons entering this RCS Competition (the “Competition”) agree to be bound by the terms and conditions of the Competition.
3. All entrants to the Competition do so entirely at their own risk.
4. This Competition runs from Monday, 29 March 2021 until Sunday, 25 April 2021 (the “Competition period”).
5. To enter the Competition, the entrant must spend any amount using their RCS Store Card between Monday, 29 March 2021 and Sunday, 25 April 2021. This will enter the customer’s name automatically into a lucky draw to stand a chance to win a Pick n Pay voucher to the value of R3500.
6. Each RCS may, in its sole discretion, extend this date for any reason whatsoever. The winner will be notified telephonically within 1 (one) week following the Competition Draw Date. In the event that RCS is unsuccessful in contacting the winner, a new winner will be randomly drawn and shall be contacted. The Prize will be a Pick n Pay voucher to the value of R3500, and maybe redeemed before the expiry date stated in the voucher.
7. There are no entry fees for the Competition. Entrants may enter as many times as they wish during the competition period.
